The mission includes business programming in Kazakhstan and participation at the 23rd International Uzbekistan Oil and Gas Conference and trade show (OGU).

Kazakhstan

The Kazakhstan programming includes industry meetings, a seminar, a networking reception with KazEnergy Association Members organized by CERBA, a KCBC and KazEnergy Oil and Gas Conference, and B2B programming.

Held from May 15-17, 2019 in Tashkent, Uzbekistan, OGU is the premier oil and gas trade event in Uzbekistan, which brings together over 200 exhibitors from 25 countries seeking to meet and do business. OGU is the best attended event in Uzbekistan's oil and gas sector, taking place with official support from the Cabinet of Ministers of the Republic of Uzbekistan and Uzbekneftegaz.

- Increase the visibility of your company and its products and services
- Scout competing products and services

- Receive valuable market intelligence on the global and Central Asia energy sector

Participation Cost

The non-refundable registration fee to exhibit at OGU in the Canadian Pavilion and to participate in the Kazakhstan program is \$1,000. The pavilion requires a minimum of 10 Alberta companies exhibiting to proceed. Exhibition space is subject to availability and will be assigned by EDT on a first-come, first-served basis.

EDT reserves the right to cancel participation at the above mentioned show given insufficient industry uptake. Mission participants will also be responsible for all travel costs, accommodation and meals.

Financial Support

Eligible Alberta small and medium sized enterprises can apply for support to offset mission costs from the <u>Alberta Export Expansion Package (AEEP) - Export Support Fund or the CanExport Program</u>.

The registration deadline is Friday, January 18, 2019.
