About CEEC

- 51st CEEC meeting
- 180 delegates, the most in 5 years
- 80 companies represented
- Recently introduced a Contractor's Forum





Key Learnings

- Romania has been producing hydrocarbons for 160 years
- Romanian offshore production in Black Sea expected in near future
- Only 1/3 of homes have natural gas, demand expected to rise
- Shortage of natural gas in Europe current gas consumption = 18 TCF, forecast to consume 29 TCF by 2030
- Europe gas market currently pays \$6 8/MCF USD
- Romania has great undiscovered hydrocarbon potential, (Paleozoic has hardly been drilled) but that it is a difficult country to work in with permitting and access being high on the list of onshore operators complaints and exploitation of the Black Sea gas with serious frustrations.
- Market conditions and the regulatory framework remain difficult, in conditions in which the effective taxation applied to the oil and gas industry has increased with each year, the level of royalties and other similar taxes (the tax on windfall gains obtained as a result of price deregulation in the gas sector, the tax on special constructions, the tax applied to revenues from crude oil exploitation) increasing during 2014 -2016 from 15% to 17.5%.

Azerbaijan – acreage open for direct negotiation with government


Poland – conventional & unconventional tight gas, 5 blocks open Q3 2019 Hungary – 8 blocks opens June 2019




Black Sea, Depth to Break-up Unconformity



2 OMV Petrom Upstream, Black Sea Cretaceous Reservoir Analogues, 10.05.2019




Histria Canyon and the "Buried Hill" traps
